



3.	Names of Yoga Council members who got selected for more than one time, in last ten years.	Dr. K.G. Bhatt was nominated twice during the last ten years.
4.	How many Muslim candidates were invited, selected or sent abroad as yoga trainer/teacher during World Yoga Day 2015.	The Council has not sent any member abroad as Yoga trainers/teachers during World Yoga Day 2015.
